Positivo Tecnologia acquires technology components both locally in Brazil and internationally. Most purchases are made outside Brazil (90%), with only 10% being local. Many input manufacturers are located in Asia.

Positivo has a Procurement team based in Asia (with offices in Taipei and Shenzhen) to strengthen supplier relationships. The company extends its values and policies to its supplier network, requiring ISO 14001 and ISO 9001 certifications. Additionally, we consider environmental, health, and social responsibility standards.

Responsibly obtaining minerals is crucial for economic progress, poverty reduction, and social well-being. When we at businesses as manufacturers opt for conflict-free minerals, we actively support the development of secure and stable mining regions, leading to a more sustainable global environment.

Since 2019, Positivo has focused on responsible procurement of Conflict Minerals, aiming for a 30% increase in supplier compliance by 2023.
